

**“MELTING POT 2018”
NATIONAL EXHIBITION**

CAIRNS REGIONAL GALLERY 30 November 2018 -6 January 2019

The Exhibition is open to the public and free entry.

CONDITIONS OF ENTRY

1. All entries must be the original work of the entrant or entrants (if joint work) executed within the last 24 months and not having won a previous award.
2. Entry Form and an administration fee of **\$25.00 per entry for members and \$30 per entry for non-members** to be forwarded to reach the following address before **Friday 9 November 2018** “MELTING POT 2018”. Cairns Potters Club Inc. P.O. Box 1470 Cairns. Qld. 4870
Each entrant may submit a maximum of three (3) works. Works are restricted to a maximum weight of 25 kg (each piece) and must not exceed 2m in any one direction. However, work must be predominantly ceramic or glass material.
3. Work to be forwarded or delivered to Melting Pot 2018 Cairns Art Gallery Cnr. Shields and Abbott Sts. Cairns by **27 November 2018 between 10 am and noon**. Alternative arrangements may be made by contacting Lone White 07 40537508 or Christina George 07 40532240.
4. All works must be marked with the entrant's name and address together with price or marked “not for sale” (N.F.S.). A series of works must have one price to cover the set. Individually priced works must be entered separately.
5. All works for sale shall be subject to 33 1/3% sales commission.
6. Entrants should note that all work, including moulds, be the original unaided work of the entrants. Commercial moulds are not accepted and will not be judged.
7. The Exhibition will be on display at the Cairns Regional Gallery 30 November 2018 to 6 January 2019.
Work must be collected between 10 am and noon on Monday 7 January 2019 from the Cairns Art Gallery. Works not collected by this time or for which clear and concise instructions have not been received, will be removed and stored at the entrant's expense and a fee of \$5 per item per day will be charged. After three weeks uncollected entries will be disposed of, to defray costs - without reference to the competitor.
8. Should any dispute arise for which no specific rule is laid down, the matter will be determined by the Executive committee, whose decision will be final.
9. All entries must be securely packed and delivered to the Committee free of all charges. Entrants are responsible for packing, freight and complete insurance cover on their work when in transit. While on display at the Gallery the artworks will be covered by the Gallery's insurance scheme. All reasonable care in handling work submitted will be taken but no liability will be accepted for the loss of, or any damage to any article while in the custody of the committee or committee's agents. All works requiring suspension must have appropriate fixtures for hanging and concise instructions. Contact Ashleigh Campbell at the gallery prior to entry for concise instruction.
10. The judge will be Sharon Jewell. Awards will be announced at the official opening to be held at 6 pm. on 30 November 2018.
11. The entries will be viewed by the judge, but only works selected by her will be exhibited. The judge's decision will be final and no correspondence entered into.
12. Entrants shall allow all exhibits to be reproduced by newspapers, television etc. without fee for the exhibition and further promotional use.

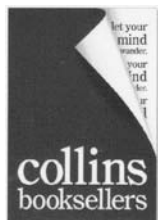
